Pre-departure

Guests travelling from Seychelles to Henri Coandă International Airport (OTP)

All travellers must produce a PCR test taken not more than 72 hours before departure and present the test result certificate at check in. Exempted from the COVID-19 PCR test are:

- Children of 4 years and below.
- Members of the diplomatic mission and consular offices
- Holders of diplomatic and service passports, as well as members of their families.
- Passengers holding a SARS-CoV-2 virus vaccine certificate (two doses) with at least 10 days between the date of the second dose and the date of entry into Romania.
- Passengers holding a medical certificate confirming they tested positive for SARS-CoV-2 virus infection issued at least 14 days and at most 90 days before arrival.
- Passengers with a test proving presence of IgG antibodies taken at most 14 days before arrival.

All passengers are required to complete the Passenger Locator form below or may equally fill up the online form at <https://chestionar.stsisp.ro/>. Copies must be presented to the authorities upon arrival.

Please check the requirements of the country you are travelling to as the travel regulations change frequently.

Measures taken

- Disinfecting surfaces after every flight.
- The cleaning process includes a wipe down of surfaces and areas such as windows, tray tables, armrests, seats, air vents and overhead lockers in the cabin, lavatories, galleys and crew rest areas.

Onboard

- Passengers will be advised to board the aircraft by rows, in a specific numerical order, as per their assigned seat.
- Each passenger will undergo one temperature screening at the aircraft door before final boarding approval is given.
- Masks will be required for everyone (6 years and above).
- Blankets and pillows will be available.
- Streaming in-flight entertainment will be available on your own device.
- SEZ-OTP is a hot lunch after take-off and a hot dinner before landing.
- OTP-SEZ is a snack upon departure, and a hot breakfast before arrival.
- Complimentary alcohol and hot drinks will be served.

Arrival in Bucharest

- Upon landing, passengers will need to observe the health and safety measures set by the authorities.
- Domestic travel is not restricted, but some conditions may apply.
- Face masks are mandatory.
- Observe social distancing of 2 metres and COVID-19 safety rules.
